

# USG SECUROCK® BRAND GLASS-MAT ROOF BOARD LIMITED WARRANTY

## WHAT IS COVERED?

United States Gypsum Company ("USG") warrants that its USG Securock® Brand Glass-Mat Roof Board ("Product") in all available thicknesses (1/4", 1/2" and 5/8") shall be free from defects in materials and factory workmanship.

This warranty extends to dealers who sell our products, contractors who install our products and all owners of the building within the warranty period.

## HOW LONG DOES COVERAGE LAST?

The warranty runs for a period of two (2) years beginning on the date of installation of the Product.

## WHAT IS NOT COVERED?

USG shall not be responsible for any loss resulting from any of the following:

- Storage and installation practices not in accordance with USG's published recommendations and specifications (see USG submittal sheet RF32), including but not limited to, the following:  
"Keep USG Securock Glass-Mat Roof Board panels dry before, during and after installation. USG Securock Glass-Mat Roof Board should not be installed during rains, heavy fogs and any other conditions that deposit moisture on the surface of the board. Apply only as much USG Securock Glass-Mat Roof Board that can be covered by final roof membrane system in the same day. Avoid exposure to moisture from leaks or condensation."
- This warranty does not cover defects resulting from the use of other manufacturers' products unless these products are specifically recommended or approved in writing by United States Gypsum Company in connection with the use of the Product.
- Mold, mildew, insects, fungi, algae, bacteria and similar conditions.
- Failure of the owner to maintain the building with reasonable care.
- Improper design, application or installation of any portion or component of the structure or roofing system, or failure, distortion or structural movement of the walls, foundation, or any other portion or component of the structure or roofing system, including settling of the building or movement of the framing members.
- Use of product other than its intended use.
- Causes such as: Impact with objects, high force winds, earthquake, flood, fire or other acts of nature; or any other cause beyond USG's control.

## WHAT WILL USG DO?

USG will, at its option, replace the goods or refund the purchase price, and, where the product has already been installed, pay reasonable labor costs to fix damage caused by a defect in the product, up to a maximum amount equal to two (2) times the original uninstalled purchase price of the nonconforming Product.

## HOW DO I GET SERVICE?

Notify USG within 30 days after discovering a possible defect of the Product and before beginning any permanent repair. This notice should describe the possible defect and include the date the Product was installed. Photographs or videotape of the damaged area are often useful and should also be submitted if available.

The Owner must allow USG's agent to access the roof and other part of the building where the Product is installed to inspect the Product. The original invoice for the Product and installation may be required for settlement in order to establish that the defect has occurred during the warranty period. For further information contact:
