shall be free from defects in materials and workmanship at the time of manufacture and meet all the performance parameters set forth in the corresponding USG submittals for each Product in effect at the time of purchase of the Product. The specific claims in the submittal sheets are incorporated by reference in this limited warranty.

This limited warranty extends to dealers who sell our products, contractors who install our products and all owners of the building within the warranty period.

HOW LONG DOES COVERAGE LAST?

This limited warranty runs for a period of 10 years from the date of purchase of the Products.

WHAT IS NOT COVERED?

USG shall not be responsible for any loss resulting from any of the following:

- Storage, design, handling, moisture levels, maintenance, use or installation practices that are not in accordance with the current published recommendations and specifications of USG (see corresponding submittals at usg.com or usgperformanceflooring.com) and Shaw Industries (see shawfloors.com).
- Failure to maintain the building or floor with reasonable care.
- Abuse, neglect or intentional acts of destruction.
- Staining due to mold, mildew or bacterial growth, or any other discoloration of the flooring.
- Failures due to outside sources of water, such as where outside grade is above substrate, or moisture caused by faulty (or lack of) vapor retarder under the concrete substrate slab per ASTM E1745, sprinklers, overflow drains not directed away from the foundations or flooding.
- Products that are not manufactured by USG or the use of products that are not compatible with each other.
- Earthquake, flood, fire, or other acts of God or nature, or any other cause beyond USG's control.
- Failure to comply with the terms and conditions of this limited warranty.

WHAT WILL USG DO?

USG will, at its option, replace the non-conforming Product or refund the purchase price, and, where the Product has already been installed, pay full replacement cost of equivalent flooring material on the affected area. Replacement of flooring materials, labor, and adhesives for affected areas will be determined by USG. USG reserves the right to send a representative to inspect any installation before any remedial actions.

HOW DO I GET SERVICE?

To make a claim under this limited warranty, you must notify USG in writing no later than 30 days from the date the claimed defect was discovered or should have been discovered on reasonable inspection, and before beginning any permanent repair. In addition, no claim may be brought more than 30 days after the end of the warranty period regardless of the date of discovery of the alleged defect. This notice should describe the possible defect and include the date the Product was installed and the name and address of the contractor who installed the Product. Photographs and videotape of the damaged area are often very helpful. Please also include any sales receipt, invoice or other evidence indicating the date of installation.
