

USG SHEETROCK® BRAND GLASS-MAT PANELS MOLD TOUGH® AR AND VHI FIRECODE® X LIMITED WARRANTY

WHAT IS COVERED?

United States Gypsum Company (“USG”) warrants that its USG Sheetrock® Brand Glass-Mat Panels Mold Tough® AR and USG Sheetrock® Brand Glass-Mat Panels Mold Tough VHI (“Products”) shall be free from manufacturing defects and meet or exceed all the criteria for ASTM C1658. In particular, USG Sheetrock® Brand Glass-Mat Panels Mold Tough AR and USG Sheetrock® Brand Glass-Mat Panels Mold Tough VHI meets all the performance parameters described in USG submittal sheets WB2750 and WB2749. The specific claims in the submittal sheets are incorporated by reference in this warranty.

This warranty extends to dealers who sell our products, contractors who install our products, and all owners of the building within the warranty period.

In addition, USG further warrants to the contractor installing the Products that they will not delaminate or deteriorate for up to 12 months after installation, with the exceptions of hurricanes, tropical storms, tornadoes, high winds, hailstorms, earthquakes, sandstorms, and immersion in pooling or cascading water.

HOW LONG DOES COVERAGE LAST?

The warranty against all manufacturing defects runs for a period of three years beginning on the date of installation of the Products in the building. The contractor-specific warranty relating to installation of the Products runs for a period of 12 months from the time the Products are installed.

WHAT IS NOT COVERED?

USG shall not be responsible for any loss resulting from any of the following:

- Storage, design and installation practices not in accordance with the published recommendations and specifications of USG (see USG submittal sheets WB2750 and WB2749).
- Structural movement or defects in the manufacture or application of other manufacturers' materials.
- Moisture intrusion defects including insect, fungus, bacteria and mold infestation.
- Failure of the owner to maintain the building with reasonable care.

WHAT WILL USG DO?

USG will, at its option, replace the goods or refund the purchase price, and, where the Products have already been installed, pay reasonable labor costs to fix damage caused by a defect in the Products, up to a maximum amount equal to two (2) times the original uninstalled purchase price of the nonconforming panels.

HOW DO I GET SERVICE?

As soon as practical, and in any event within thirty (30) days of the time you discover a problem, write to us, including a brief description of the problem. Photographs and videotape of the damaged area are often very helpful. Please also include any sales receipt, invoice or other evidence indicating the date of installation.
